- All account credentials are encrypted and securely stored.
- Access to client data is strictly limited to authorized staff members.

- Our systems are protected with up-to-date firewalls, SSL encryption, and secure access controls.

We implement industry-standard security measures to protect your information.

We retain your information:

- As long as your account is active
- As needed to comply with legal obligations
- Until you request deletion (in applicable cases)
