

US CAPITAL – PAMP EA Powered

Applies to all clients using our Prop Firm Account Management Program

SECTION 1: ACCOUNT & SERVICE RULES

1.1 – One Subscription = One Account

Each PAMP subscription covers one (1) prop firm account only. Submitting multiple accounts under the same plan is not allowed.

1.2 – Valid Account Ownership

Only accounts personally owned by the client are accepted. Submitting accounts that belong to third parties or unknown individuals is strictly forbidden.

1.3 – Prop Firm Must Be Supported

The submitted account must belong to a supported prop firm (e.g., FundedNext, FTMO,, TFT, etc.). We do not support accounts from banned or unverified platforms.

1.4 – Login Credentials Must Be Accurate

All login details provided (MT4/MT5, investor password, server, platform type) must be correct. Invalid or missing credentials delay or cancel service activation.

1.5 – No Manual Trading

Once the EA is connected to your account, manual trading is strictly prohibited. Interfering with trades will result in account disqualification.

1.6 – No EA Tampering

Clients must not attempt to:

- Modify EA settings
- Disconnect or restart the EA
- Use third-party software to interfere with the system

1.7 – No Password Changes During Active Period

Changing your account password without notifying the team will cause disconnection and service interruption.

1.8 – Account Type Must Be Challenge or Funded

PAMP is only designed for challenge or funded accounts – not demo accounts or personal live trading accounts.

SECTION 2: BEHAVIOR & ETHICS

2.1 – Respect the Team

All communication with the US CAPITAL team must remain professional. Any form of aggression, insult, or disrespect results in immediate disqualification.

2.2 – Stay Available

Clients must respond to emails, Telegram messages or form requests within 7 days. Non-responsive accounts may be paused or removed.

2.3 – No Spamming or Self-Promotion

Advertising, spamming or posting external offers in our Telegram or Discord communities is not allowed.

2.4 – Private Service Access Only

Do not share your access (forms, documents, strategies, credentials) with anyone. This service is confidential and private.

2.5 – Clear Communication Required

Use proper language when submitting information. Avoid vague answers or incomplete messages that delay your activation.

SECTION 3: PAYOUT & PROFIT SHARING

3.1 – Mandatory Payout to US CAPITAL

All payouts must be sent to our crypto wallet (USDT/BTC) as instructed. The 50/50 profit split is non-negotiable.

3.2 – No Direct Withdrawals

The client cannot receive the payout directly without prior arrangement. If it happens, they must send 50% immediately.

3.3 – Delayed or Blocked Payouts

If the prop firm delays the payout, we wait together. If they block it, we cannot be held responsible.

3.4 – Payout Fraud = Permanent Ban

Attempting to withhold or hide profits will result in:

- Permanent blacklist
- Removal from all US CAPITAL services
- No future access to our bots, teams or updates

SECTION 4: VIOLATIONS & TERMINATION

4.1 – Breach of Rules

Any violation of the above rules may result in:

- Termination of service
- Loss of client rights
- Ban from our communities

4.2 – Repeat Offenders

Clients who repeatedly ignore rules will be banned permanently, regardless of previous payments.

4.3 – Refunds Will Not Be Issued

Violation = no refund. All payments are final, as stated in our Terms & Conditions.

4.4 – Legal Action

Severe abuse, fraud or identity theft may result in legal pursuit under UAE jurisdiction.
